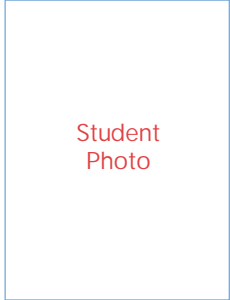

Parent Agreement - Terms and Conditions

The Parent or Legal Guardian(s) understand and accept that:

1. They are liable for payment of all applicable school fees and tuition.
2. Sinarmas World Academy has the right to decline admission to any student where the school considers it cannot adequately provide for the child's emotional, intellectual or physical needs.
3. Once enrolled, the student will remain enrolled at Sinarmas World Academy to the end of the current academic year. The student's legal guardian(s) undertake to give, in writing to the Admissions Manager, one full term's notice of termination, or a full term's fees paid in lieu of such notice.
4. The student and the student's legal guardian(s) and families will abide by the school's established policies and procedures.
5. The student is required to participate in all school activities including events, camps and field trips.
6. The school reserves the right to make student grade placements, where the school considers it necessary that a student repeat a grade.
7. Students are supervised at school, on school buses, and school excursions and field trips by staff members and/or any other adults who will exercise all reasonable caution. However, the student's legal guardian(s) understand that the school and its members cannot accept any liability for accidents or incidents which may occur during these time.
8. It is the parent/legal guardian(s) responsibility to provide information without omissions or falsification and to provide all supporting documents to complete the application. In the event that it is revealed that the student's legal guardian(s) deliberately falsified or omitted information, Sinarmas World Academy reserves the right to discontinue an enrolled student.
9. Sinarmas World Academy retains the right to suspend or terminate a student enrollment, should the student not comply with the rules or guidelines of the school or should the Executive Principal determine that the student is unable to adequately benefit from the education that Sinarmas World Academy offers.
10. The student's legal guardian(s), are responsible for obtaining necessary documentation which may include the student's visa, resident permit or any other legally required permit/document (if applicable) when the student is enrolled at Sinarmas World Academy.
11. Sinarmas World Academy has the right to administer drug testing at its sole discretion.
12. In the event of a medical emergency, SWA will act on their behalf to administer emergency treatment and/or engage professional medical services.
